In 2020, University Heights Center responded to the community's  
evolving needs during the pandemic, remaining open to provide emergency  
child care for essential workers, pivoting arts and cultural  
programming to an online platform, increasing human services to support  
our more marginalized populations disproportionately affected by  
COVID-19, and continuing to provide free and below market-rate rentals  
to long-term nonprofit resident organizations. Since 2009, University  
Heights Center has invested nearly \$5 million in capital improvements  
to preserve the historic landmark and is currently in the final stages  
of raising the remaining funds of the Elevator Installation Project  
that will give full accessibility to all classroom and event spaces.
